



'3KW Solar Giveaway' Competition Terms and Conditions:

Promoter: All Energy Queensland Pty Ltd (AEQ), ABN 37 619 685 239, PO Box 373 Trinity Beach Qld 4879, 0418 854 020.

1. Eligibility:
 - a) To enter the competition, you must leave your details on the AEQ landing page.
 - b) By entering this competition, you agree to, accept and are bound by these terms and conditions.
 - c) If the Prize involves a third party, the winner is bound by the third party's terms and conditions.
 - d) This competition is open to all residents of the Cairns Regional Council region, except for the employees of the promoter, its subsidiary companies, their families and any other company connected with the competition.
 - e) Should the winner live outside Cairns, but within a 300km travelling distance, there will travel costs incurred which must be paid by the winner.

 - c) If the winner would like the system installed on a tiled roof then additional costs will apply.
 - d) The winner must have electricity running to their property where they would like the system installed.
 - e) The prize must be installed before 30th November 2019 and terms and conditions apply.
